3. Upon termination of employment, the Employer shall inform MDEC of the same, so that necessary steps can be taken to cancel the EMPLOYMENT PASS. Any other passes tied to an EMPLOYMENT PASS, such as a Dependant's Pass / Social Visit Pass / Student Pass / Permission To Study, must be produced for cancellation along with the EMPLOYMENT PASS.

The issuance and endorsement of the EMPLOYMENT PASS are at the discretion of the Immigration Department of Malaysia and are subject to status clearance, and the provisions of the Immigration Act 1959/1963 and the Immigration Regulations 1963. The issuance and endorsement of the EMPLOYMENT PASS are also subject to the approval(s) of any other relevant authorities.

The Employer is required to explain the contents of this letter to the applicant. A violation of any of the above conditions will affect the Employer and/or the applicant's future applications for issuance of passes to pursuant to the Immigration Act 1959/1963 and the Immigration Regulations 1963.
